Family Education Rights and Privacy Act (FERPA) Notification for Directory Information for the 2010-2011 School Year

During the 2010-2011 school year, the Park City School District may allow selected organizations access to "directory information." The District has declared the following information as "directory information" as provided in the act and such directory information related to students may be made public if the information is in any of the following categories:

- Student's name, address, telephone number
- Date and place of birth
- Major field of study
- Participation in officially recognized activities and sports
- Weights and heights of members of athletic teams
- Dates of attendance
- Degrees and awards received
- Most recent previous educational agency/institution attended by the student
- Current grade and teacher's name
- Yearbook photos

New federal laws under "No Child Left Behind" require schools/school districts to provide **high school** student directory information to military recruiters upon written request. Military recruiters have limited access to student information. Schools/districts must release only student name, telephone number and address unless a parent (or eligible student) has opted out of providing such information as outlined below.

A parent of a student currently enrolled (or a student over eighteen years of age) has the right to refuse to the release of any or all of the above types of information about that student as directory information. To take advantage of that right the parent (or eligible student), must notify the principal of the school he/she attends within 20 days from receiving this notice in writing that he/she does NOT want any or all of those types of information about the student designated as directory information.

If you wish to "opt-out" please fill out the back page and return it to your school administrator no later than September 15th, or 20 days after the day of your enrollment.

Please note that unless you contact the school official listed above to "opt out", your child's designated directory information can be released by the school district.

**FERPA Notification for Directory Information
